

Premise

For the past 18 years, *Videominuto* has been the promoter of the international festival of the same name. This festival has permitted both established and unknown authors, video professionals, and simple filmmakers to display their talent, through their work, to a large public at the event, to a jury of critics and personalities from the art world, and to television scouts always looking for new talent.

In recent years there has been an ever-increasing problem with legal releases and copyrights. If at first there were no specific problems with showing videos with non-original music or without copyright release forms, now this is practically impossible. This is also one of the reasons for which a DVD has never been published for the promotion of the festival and its participants on TV, satellite channels, production houses, sister festivals, etc.

In order to solve this problem, a decision was made to ask authors to sign an "**extended release**" that allows us to work freely in the ways mentioned above with the aim of promoting the festival and its participants to the maximum. Authors who choose not to participate in this type of activity may choose to sign only the "**screening release**" that has been used in past years and will exclude their work from some forms of promotion that we intend to use.

To participate in one of the competitions of the international festival Videominuto, complete and sign the following LEGAL RELEASE FORMS and send them together with your video entry to:

All rights conceded may be used by you directly or by your delegates or concessionaries."
